## ARCHIVING SCHEME 2

Funding Scheme for the  
Archiving of Programme Material

### CALL FOR APPLICATIONS

The Broadcasting Authority of Ireland (“BAI”) launched its second funding scheme for the archiving of programme material (“Archiving Scheme 2”) in June 2018. Archiving Scheme 2, like its predecessor, has been designed to provide funding support for the development of an archiving culture in the Irish broadcasting sector which will contribute to the preservation of Ireland’s broadcasting heritage.

The BAI is opening a funding round for Archiving Scheme 2 and is currently seeking applications for projects for the archiving of programme material with the specific objective of the preservation of a historic record of Irish culture, heritage and experience and in particular, that which safeguards historic material that is threatened by fragile physical condition or soon to be obsolete formats.

Archiving Scheme 2 is open to broadcasters, advertisers, persons/institutions in possession of relevant material, persons/institutions capable of carrying out work on archiving material considered to be of value to the State, and persons/institutions capable of furthering the scheme’s objectives.

Archiving Scheme 2 concerns programme material broadcast in whole or in part, or recorded for broadcast, on radio and/or television and includes advertisements. Stills and photographs produced from such material, or in the context of the recording of such material are also eligible.
