In accordance with Section 65 (8) of the Broadcasting Act 2009 ("the 2009 Act"), the Contract Awards Committee of the Broadcasting Authority of Ireland ("the BAI") hereby invites applications in writing from any person or body interested in securing a sound broadcasting contract for the provision of the following sound broadcasting service on the FM band: -

A Music-Based Sound Broadcasting Service For A General Audience Aged 35-55 Years In Dublin City & County
