De réir alt 67(3) den Acht Craolacháin, 2009 (“an tAcht”), fógraíonn an Coiste um Dheonú Conarthaí ag Údarás Craolacháin na hÉireann (“an BAI”) leis seo go bhfuil ar intinn aige an nós imeachta mear a agairt chun Conradh craolacháin fuaimne (“Conradh”) ar bhanda FM a dheonú d’fhonn an tseirbhís seo a leanas a sholáthar:

## Seirbhís Craolacháin Fuaimne a bheidh Bunaithe ar Rac-Cheol Clasaiceach, agus í Dírithe ar Dhaoine Fásta 25+ Bliana d’Aois i gCathair, i gContae agus i gCrios Comaitéireachta Bhaile Átha Cliath

Is ag Classic Rock Broadcasting Teoranta, a bhíonn ag craoladh mar Radio Nova, atá an Conradh ar seilbh faoi láthair, agus tá an Conradh sin le dul in éag an 30 Meitheamh 2020. Ceanglaítear ar aon duine, seachas an sealbhóir, ar spéis leis nó léi an tseirbhís craolacháin fuaimne atá bunaithe ar rac-cheol clasaiceach a sholáthar, aighneacht a dhéanamh i scríbhinn á rá gur mian leis/léi iarratas a dhéanamh ar an gConradh a dheonú, agus suim **€20,000** a thaisceadh leis an BAI faoi **12 meán lae Dé hAoine, 25 Deireadh Fómhair 2019**. Beidh an éarlais sin in-aisíoctha, má dhéantar iarratas ar an gConradh a dheonú a chur faoi bhráid an BAI dá éis sin, de réir alt 65 den Acht.

Tabhair faoi deara nach measfar gur iarratas ar an gConradh é Léiriú Intinne arna chur isteach mar fhreagra ar an bhfógra seo. Eiseofar cuireadh ar leithligh chun iarratas a dhéanamh ar an gConradh a dheonú de réir alt 65(8) den Acht, má mheasann an BAI gur cuí déanamh amhlaidh. Má eisítear cuireadh den sórt sin, is Conradh é ar sheirbhís craolacháin fuaimne ar bhanda FM a bheidh bunaithe ar rac-cheol clasaiceach, agus í dírithe ar lucht éisteachta 25+ bliana d’aois i gCathair, i gContae agus i gCrios Comaitéireachta Bhaile Átha Cliath agus mairfidh sé ar feadh tréimhse deich (10) mbliana, agus tosóidh sé an 1 Iúil 2020. ## NOTIFICATION OF INTENT TO INVOKE THE FAST-TRACK APPLICATION PROCESS FOR THE AWARD OF A SOUND BROADCASTING CONTRACT

In accordance with section 67(3) of the Broadcasting Act 2009 (“the Act”), the Contract Awards Committee of the Broadcasting Authority of Ireland (“the BAI”) hereby announces its intention to invoke the fast-track procedure for the award of a sound broadcasting contract (“Contract”) on the FM band for the provision of the following service:

## A Classic Rock Music-Based Sound Broadcasting Service, Targeting Adults Aged 25+ Years in Dublin City & County & Commuter Belt

The contract, currently held by Classic Rock Broadcasting Limited and broadcasting as Radio Nova, is due to expire on 30th June 2020.

Any person, other than the incumbent, interested in providing the classic rock music-based sound broadcasting service is required to submit in writing that he/she wishes to apply for the award of the Contract, and to deposit the sum of **€20,000** with the BAI by **12 noon on Friday, 25th October 2019**. Such deposit is refundable, if an application for the award of the Contract is subsequently submitted to the BAI, in accordance with section 65 of the Act.

The written submission must be completed in accordance with the format set out in the “Guide to Submissions: Statement of Intent” document in respect of the above sound broadcasting service, which is available on the BAI’s website or on request from the BAI’s offices (email: [licensing@bai.ie](mailto:licensing@bai.ie) or call 01 644 1200).

Please note that a submission of a Statement of Intent in response to this notice will not be regarded as an application for the Contract. An invitation to apply for the award of the Contract in accordance with section 65(8) of the Act will be issued separately, should the BAI consider it appropriate to do so. Such an invitation, if issued, will be for a contract for a classic rock music-based sound broadcasting service on the FM band targeting an audience aged 25+ years in Dublin City & County & Commuter Belt and will be for a period of ten (10) years, to commence from the 1st July 2020.
