Section 70 of the Broadcasting Act 2009 (“2009 Act”) provides for the award of a Television Programme Service Contract on the recommendation of the Contract Awards Committee of the Broadcasting Authority of Ireland (“the BAI”). Section 66 of the 2009 Act requires the Contract Awards Committee to consider and to determine the most suitable applicant in respect of the Television Programme Service contract. The Television Programme Service is a national free-to-air service.

The Contract Awards Committee hereby invites applications in writing from any person or corporate body interested in securing the Television Programme Service Contract.

Applicants’ attention is drawn to the relevant criteria laid down in Section 66 of the 2009 Act and to the duties that will be imposed on the successful applicant under the various provisions of the 2009 Act, including, in particular, the programming requirements specified in section 70.

A *Guide to Submissions for the Television Programme Service Contract* (“the Guide”) is available on the BAI’s website ([www.bai.ie](http://www.bai.ie)) or on request from the BAI’s offices (email [licensing@bai.ie](mailto:licensing@bai.ie) or call 01 644 1200). The Guide contains relevant information in respect of the Television Programme Service and the application procedure.

## **Applications for the service must be completed in accordance with the detailed format prescribed in the Guide.**

The closing date for receipt of applications is **12 noon on Wednesday, 4 January 2023**. Applicants should note that the BAI reserves the right not to award a contract.
